Commissioner Muzaffarabad Masood Ur Rahman said in a detailed lecture on the state's laws and society's responsibility that the law is mainly made for the benefit and improvement of the people of the state. The government is within the state and the government makes laws through the assembly, the judiciary interprets these laws and the administration follows the laws and orders them.

administration follows the laws and orders them. States take into account universal principles of law-making and international charters before making laws. The laws which are made according to the universal principles of law are delayed and the laws which are made in bad faith cannot be followed and are not implemented. A law that goes against the basic principles of law is not recognized and states that make such laws do not last long. Like there are black laws like TADA and POTA in IOJK. He said that the law is respected in civilized societies. Every individual in the state must respect the law and follow it. Law is a collective code containing principles, the implementation of which is everyone's responsibility. The law applies to all and no one is exempt from the law. The main purpose of every law is to strengthen society. The law keeps society moderate. He said that the establishment of the Kashmir Policy Research Institute is a commendable initiative. And for the first time in Azad Kashmir, such a stable institution has been created at the government level, which is on the path of development A one-month internship program is a great endeavor for university students and for the first time in Azad Kashmir, such an internship program is being organized under the auspices of an institution. In civilized countries, such programs are started at the high school level and the new generation is introduced to the state institutions and systems during education.

Occupied Kashmir. India's actions after August 5, 2019 and abrogation of Article 370 and 35A are against the UN resolutions. Kashmiris have not recognized the illegal occupation of India and will not do so. The Maharaja of Kashmir tried to join Kashmir with India but the Kashmiri people started struggle for independence from Dogra. Under the Amritsar Treaty, the present map of the state of Jammu and Kashmir became clear. Under the Treaty of Amritsar, Dogra Gulab Singh bought the state of Jammu and Kashmir from the British government for 75 lakhs Nanik Shahi. He said that Kashmir issue is not a border dispute but it is an issue of Kashmiri nation's right to self-determination. The issue of Kashmir is on the agenda of the United Nations. India went to the United Nations Security Council and the United Nations Security Council said in its resolution that no region of Kashmir can decide to annex itself. Accession or independence will be decided by the people of the state of Jammu and Kashmir through their right to self-determination. He also gave a detailed lecture on the freedom of Kashmir, history of Kashmir, legal status of Kashmir issue and other issues. At the end of the program there was a question-and-answer session.

government will not give up the powers given under the thirteenth constitutional amendment. There is no question of abdication of the powers of the Azad Kashmir Government or the Assembly. Prime Minister Azad Kashmir Sardar Tanvir Ilyas also wants to expand the Azad cabinet as we wished that the number of Azad Kashmir's cabinet should increase for better performance in all sectors. The entire leadership of Azad Kashmir is united on the issue of the state constitution and the powers of the government. There should be an increase in women's seats in the Legislative Assembly. Just as 12 per cent has been reserved for women in the local body elections, the quota of women in the Legislative Assembly should also be increased. At present, only 5 seats are reserved for women in the Azad Kashmir Legislative Assembly. If it is not a step of education, then education should not be a condition for the representatives of the local bodies. Real success comes from truth. Professor Taqdees Gilani also said that the government of Azad Kashmir is taking effective steps to include women in the national stream. Steps are being taken to reduce poverty and various projects are under consideration to provide opportunities for the new generation of workers

employment opportunities in the private sector apart from the public sector. Within Azad Kashmir, women are far ahead in higher education but there are no employment opportunities for women. If governance and transparency are improved, the investment will come within the region. For investment, it is necessary to provide facilities and incentives to the investor. Human resources, water and tourism are three major resources that we have to utilize to take the state on the path of development and that will also reduce the employment problem. The guest speaker said that the total budget of Azad Kashmir is 163.5 billion rupees, in which 83 per cent of the budget is nonbudgetary and 17 per cent is budgetary. 44 percent of the non-developmental budget is provided by the Azad Kashmir government from its own resources, while 55 percent is provided by the Pakistan government as part of federal taxes. The entire development budget is paid by the government of Pakistan as a grant. Out of which 70 percent is spent on infrastructure, 12 percent on agriculture and industries and other productive sectors and 19 percent on services. The administrative structure of Azad Kashmir is working on the pattern of Pakistan. There is a parliamentary system of government in Azad Kashmir. Azad Kashmir has the resources to generate 9,000 megawatts of electricity, currently 2400 megawatts of electricity is being generated in Azad Kashmir, while the total electricity requirement of Azad Kashmir is 280 megawatts. Azad Kashmir is leading among all parts of the country in terms of education rate. Literacy rate in Azad Kashmir is 77%. Azad Kashmir is also very good in terms of law and

order. 2 to 15 million tourists come to Azad Kashmir annually. Azad Kashmir has a better situation than Pakistan in terms of human development. There is better infrastructure within Azad Kashmir, so there are issues of governance; concrete steps are needed to improve governance. Within Azad Kashmir, no one is landless and there is no feudal system. Apart from one lakh government employees, 1.5 lakh Kashmiris are permanently employed abroad. Governance, environmental problems, economic problems and daily life are among the major problems of the region.

Dr. Idrees Abbasi said that a parliamentary democratic system is running successfully

in Azad Kashmir. Citizens of Azad Kashmir have all fundamental rights. Within this area, significant progress has been made in every sector since 1970. In 1947, electricity was available only in the cities of Muzaffarabad and Mirpur, while today 90% of the people of Azad Kashmir have access to

electricity. A constitution is the document of any state that defines the powers of the three main pillars of the state. The constitution is an agreement between the citizens and the same constitution is also an agreement between the citizens and the state. Dr. Idris Abbasi said that after the constitutional amendment the Azad Kashmir Interim Constitution got the status of Constitution. The Constitution grants equal rights to all citizens, with the Thirteenth Amendment adding new rights including the right to transparent trial education, free and compulsory education for children between the ages of five and sixteen, access to information Right, protection from inhumane punishment, protection of cloak and wall, right to protection from torture, protection of languages and culture and other rights are included. The right to life is not suspended even in emergencies. The Supreme Court of Azad Kashmir also has advisory powers to hear appeals against the decisions of the High Court. The Supreme Court has jurisdiction over appeals as well as writ petitions

Very soon, the first IT park will be built in the public sector in Azad Kashmir. Employment opportunities are limited due to the lack of the private sector in Azad Kashmir. The establishment of a think tank in the name of Kashmir Policy Research

The main purpose of establishing this institution is to provide opportunities for research purposes. Students of universities are being given training related to research. Guest Speaker Mansoor Qadir Dar said that the budget of Azad Kashmir is very limited. Until last year, it was 10 billion rupees. The normal budget of Azad Kashmir is fulfilled by state resources, while the external budget is provided by the government of Pakistan. This will create more employment opportunities. When the budget is spent on the productive sectors, it will increase the income of the state, when the state has income, the economic work will be done automatically. Our budget is being spent on infrastructure, the production sector and the provision of services. He said that the unemployment of educated youth in Azad Kashmir is becoming a big and serious problem. It needs serious attention. The government is taking steps to reduce unemployment in Azad Kashmir, and many incentives including tax exemptions have been given to the private sector for investment. Policies have been formulated for various sectors to benefit the people of the state from the state's resources.

Topic: Indian Illegal Annexation of IIOJK: Demographic Changes

A seminar was organized in the Institute on the occasion of August 5 Black Day. Mian Danyal Ali Qureshi, a student of Azad Kashmir University, Noor Ul Qamar, a student of National Defence University, Ch Tahir Bashir, a student of UAJK, Osama Ali Kazmi, a student of UAJK also addressed the ceremony. While the duties of compare were performed by Mian Danyal Qureshi, a student of UAJK, while Syed Saqib Geelani received the blessing of reciting the Holy Quran. Addressing the ceremony, Raja Muhammad Sajjad Khan said that in Occupied Kashmir, India and its occupying army have surrounded the entire valley. 1095 days have passed since the siege of the Indian army in Kashmir. Since August 5, 2019, 662 people have been martyred, including 13 women, and 278 people have been beheaded. 38 women have been widowed and 17973 civilians have been arrested and 125 women have been humiliated as a war tactic. Despite all the atrocities, the spirit of freedom of Kashmiris has not decreased and the resistance of the Kashmiri people against India continues with full intensity. We have to convey the voice of Kashmiris engaged in the freedom struggle to the world. We have to draw the attention of the international community to the violations of human rights in Occupied Kashmir. Today in Occupied Kashmir highly educated young people are joining the practical cause of freedom. There are many fields for research on the Kashmir issue for the youth of Azad Kashmir. He said that when we raise our voice from our camp in favour of the people of Occupied Kashmir, their morale rises. The people of Pakistan and Azad Kashmir are standing like a rock with the Kashmiris who are engaged in the struggle for freedom. In revenge for the event, the students of the internship program held at the Kashmir Policy Research Institute took out a protest rally in the form of queues from the Kashmir Policy Research Institute to the Social Welfare Complex on the occasion of Exploitation Day. And black flags were hoisted with anti-India slogans written on them. The participants in the rally raised loud slogans against India and demanded the international community take notice of India's constitutional terrorism in Occupied Kashmir. Article 370 of India. Occupied Kashmir has been turned into the world's largest human prison and 9 lakhs are occupied by the Indian Army. He is engaged in serious violations of human rights in Occupied Kashmir under the black laws. The Hurriyat leadership is under arrest. Freedom of expression is banned; thousands of innocent youths are arrested. But we want to make it clear to India that it cannot deprive Kashmiris of their birthright through coercion and violence. Kashmiris will continue their struggle till independence from India. Today, we assure the Kashmiris across the country that we will fulfil and continue to fulfil the promise made to them. The people of Occupied Kashmir are not alone in the war of independence; the people of Azad Kashmir and Pakistan are behind them. Raja Muhammad Sajjad Khan said that the extremist government of India under Hindutva. Occupied Kashmir has been turned into the world's largest human prison. India is trying to change the identity and demography of Kashmir by abrogating Articles 370 and 35A. But the Kashmiris have continued their struggle for freedom with courage and determination and there has been no decrease in the spirit of freedom of Kashmiris. Kashmiris will not give up their right to self-determination. This struggle for freedom in Kashmir is a war of defence of Pakistan. Kashmir is a defensive enclave of Pakistan. It is the responsibility and duty of those living in the camp to draw the attention of the international community to Indian atrocities and violations of human rights in Occupied Kashmir. Since August 5, 2019, a new series of oppression and violence has been going on in Occupied Kashmir and this time the economy of Kashmiris has been attacked to weaken Kashmiris economically

Pakistan is the fifth largest country in the world, which has been enriched by nature with a wealth of natural resources, but we have not been able to utilize these resources. The guest speaker said that when the governments make agreements, they keep the interest of the country and the nation in mind, but during some agreements in Pakistan, the interest of the country and the nation were not taken into account. Due to the IPPs agreements, electricity is becoming expensive in Pakistan and the country had paid a huge amount. He said that for the development of the industry, electricity must be cheap, which is why the industry in China is developing rapidly. Loans from abroad and institutions should be taken for those things and projects that can develop the productive sector and generate income sources in these sectors through investment.

Former Prime Minister Azad Kashmir Raja Muhammad Farooq Haider Khan was the

guest speaker of the internship program. Secretary Kashmir Cause and languages Mr Ejaz Hussain Lon informed the participants about the purpose and objective of the internship program. And welcomed the guests and appreciated his services in wonderful words. Director, Kashmir Policy Research Institute Raja Muhammad Sajjad Khan said that



under the auspices of Kashmir Policy Research Institute, a one-month internship program has been started for the students of various universities, under which the students will be trained during the first three weeks. Lectures have been given on various topics and they will also be given training on research methodology. Guest speaker said that Pakistan is the only country in the world that has raised its voice for the right of self-determination of Kashmiris. The new generation should take heed of those who spread negative propaganda against Pakistan in Azad Kashmir. It is in Pakistan's interest to bring Kashmiris forward to highlight the Kashmir issue at the international level. When the Kashmiris present their problem at the international level, the world will listen to them because the real parties to the Kashmir problem are the Kashmiris. The thirteenth constitutional amendment restored the powers of the Azad Kashmir Legislative Assembly and the Azad Kashmir Government. To effectively highlight the Kashmir issue at the global level, there is a need for a full-fledged political movement whose slogan should be the right to self-determination. In the context of the current situation, Pakistan should make a new policy to highlight the Kashmir issue at the global level, in which the face of the Kashmiris should be shown and Pakistan should support the Kashmiris

The guest speaker said that Kashmir Freedom Movement is currently going through the most critical period; Hurriyat leadership is either arrested or detained. A large number

of youths are in custody. The martyrdom of Syed Ali Geelani and the case of Malik Yasin are in front of everyone. In such circumstances, it is the responsibility of the people of the camp to convey the voice of Kashmiris to the world. Kashmiris living abroad are our great strength and their services in highlighting the Kashmir issue at the global level. Today, India has become a major power in the world and we are begging the world. Even if it remains, the flood has removed it. He said that many big powers have interests in this region and they are working for their own interests. America is afraid of China and it wants to block China's path, for this purpose it is using India. The former prime minister said that the atomic bomb is not meant for use. We need to consider our actions and avoid idle speeches. He said that we need to highlight the Kashmir Freedom Movement on the diplomatic front. He said that the status of the Azad Kashmir government and assembly is constitutional and legal and they exist according to the resolutions of the United Nations, while the status of the Srinagar Assembly is that of a puppet. Our ancestors got their rights after a lot of struggle. In response to a question, he said that as the Prime Minister, he ended the ban on student unions in Azad Kashmir. In response to another question, he said that it is also a fact that a second Sheikh Abdullah is currently being sought in Azad Kashmir.

Topic: Recent Situation of Kashmir: Challenges and Way Forward

Former Prime Minister Sardar Attique Ahmed Khan was the guest speaker of the internship program. Director Admin Jammu and Kashmir Liberation Commission Kashmir Policy Research Institute, Raja Muhammad Sajjad Khan gave a brief introduction of the internship programme. Sardar Ateeq Ahmed said that the state of Jammu and Kashmir is a part of Kashmir geographically,



historically, and culturally. The guest speaker Sardar Ateeq Ahmed said that it is common knowledge that the issue of Kashmir is the issue of self-determination of Kashmiris.

He said that Maharaja Shamir did not join India, nor has India been able to present this fictitious accession to any world, according to research, there are no documents of Maharaja's accession. On August 12, 1947, Maharaja offered Pakistan and India a Standstill Agreement, but India rejected Maharaja's offer, and Pakistan accepted this offer on August 15, 1947. India took the Kashmir issue to the United Nations. The right to self-determination of Kashmiris has been recognized in the resolutions of the United Nations. He said that Occupied Kashmir should also be included in the CPEC. Sardar Attique Ahmed said that despite all the problems, Pakistan has the most important position in this region and no one can ignore this position of Pakistan. History is a witness that the Pakistani nation has always stood with Kashmiris and Kashmiris have always expressed eternal solidarity. The goal of Kashmiris is freedom from India. Every Kashmiri wants freedom from India. In response to a question, he said that the Muslim Conference is the largest party of Kashmiris and the leadership of this party has played the role of the vanguard in the struggle for freedom. In response to another question, he said that Kashmiris maintain their identity in all situations
